- He/she should send a brief summary of his/her achievements (a brief background about his achievements and contributions - publications, conference organized, scientific contribution etc.), contribution to ABSI and Bio-data (with Photo), all this not exceeding 250 words and signed by him/her. This should also have a mention of ABSI conferences attended in last 5 years. This information will be put forward to the members before and during the online voting.

**Election Process and Voting** – The elections will be conducted under the overall supervision of Election Committee comprising of President, President Elect, & Immediate Past President .The Secretary will guide the election process and the **President Elect (Dr DG Vijay ) will be the Returning officer.**

**Campaigning Rules** : Individuals applicants are not allowed to campaign though personal phone calls, e mails , letters or social media platforms. The election committee will circulate the biodatas of the candidates to all voters.

**Online E Voting - 9 AM on 10<sup>th</sup> July, 2024 till 19<sup>th</sup> July, 2024 5 PM .**

**Results will be intimated to the participating candidates and subsequently declared during ABSICON 2024 EC and GB meetings.**

If there is no contest the President shall declare the member elected for the post in GBM. If no nomination is received, it is on the President and President elect to nominate one person for that post. Nominated candidates will have the same rights and powers as elected candidates. The term for nominated members is for one year only.
